Convio configures the DataSync framework, allowing you to synchronize information from Convio online solutions — including registration forms, surveys, donations and advocacy — with offline donor, member or advocacy databases. An extensive data set allows you to synchronize almost any single piece of online constituent data with offline databases.

Flexible field mapping ensures that the data you gather online is synchronized with the exact field in the offline database where you want it. Convio DataSync also ensures that your online data is reliably transferred, with a configurable set of business rules that control import and export behavior.

To avoid duplicating records between online and offline databases, Convio DataSync matches similar records and offers administrators the option of using a "profile match score" to view and reconcile potential record duplications. Convio also can schedule DataSync data imports and exports with merge and collision logic that automatically generate data files and provide detailed audit logs.

DataSync provides a streamlined data synchronization process with predefined data fields of transfer. By evaluating usage over the last seven years with almost 1000 customers, Convio has compiled a list of the most useful transfer fields. By focusing data transfer to these fields, organizations can focus their attention on the elements that matter for online fundraising, advocacy and event management to achieve greater results while reducing the potential for database clutter.

High Data Integrity. Define rules for handling potential duplicates, specifying when to create a new record, merge information and more. Evaluate potential duplicate records as part of the data synchronization process. Optionally review possible duplicates before exporting to offline database(s). View log of all data synchronization operations including errors, successes and conflict resolution summaries.

Automated Synchronization. Schedule synchronization timing based upon business requirements. Import and export files with automatic File Transfer Protocol (FTP) access. Initiate synchronization process manually, at any time.




Figure 1. The "My DataSync" Tab isolates the synchronization functions that are used frequently by your organization.




Figure 2. A DataSync wizard walks you through a sequential series of synchronization steps that are particular to your custom integration.
